What Guides our Decisions?

- Decisions are based on data, recommendations, and orders from our governing officials:
 - CDC K-12 School Guidelines
 - CDC COVID-19
 - Fort Bend County COVID Data



OPERATIONS:

Arrival

Staggered Drop Off: The purpose of staggered drop off/pick up is to reduce traffic and minimize the risk of spread

Full Day Program: 7:00 – 8:00 am Academic Day Program: 8:15 – 8:30 am

Designated drive-through Time: 8:15 – 8:30 am **During this time, pedestrian traffic is not allowed.**

Screening for symptoms takes place upon entry.



OPERATIONS:

Dismissal

Academic Day Students: Use the drive-through lane, pedestrian foot traffic is not allowed during these times:

2:30 Toddler & Early Childhood

3:00 Elementary

Full Day Students: Dismissal after 3:00 pm

Parents of Toddler/EC children may enter the building for pick-up between 3:00 – 6:00 pm

Elementary, parents come to the door/gate of the Handwork Studio (EAST door) or playground, depending on time of departure. Your child will greet you outside.



Non-Pharmaceutical Interventions (NPI)

- Personal: Proper Handwashing & Face Masks (optional)
- >> **Environmental:** Frequent Cleaning and Sanitizing of commonly used areas.
- > Community:
 - > Health Screening upon entry and temperature checks after lunch.
 - > Constant monitoring of Illness & Symptoms.



NPI: Personal

> Face Masks are <u>optional</u> for adults and children.

> Washing Hands

- >> Proper handwashing (soap, lather, and wash for a full 20-seconds front, back, and in between fingers),
- > Please reinforce proper handwashing at home.

> Hand Sanitizer

- >> When soap and water are not accessible, hand sanitizer is used*
- >> Hand Sanitizer is available in every occupied room.
- > EC and Toddler students may NOT bring personal hand sanitizer, Elementary students may.

*Hand sanitizer cannot be used on children aged 2 yrs. and younger.



NPI: Environmental

FACILITY

- >> Professional Janitorial providers clean the school Monday Friday.
- > Teachers/staff sanitize classrooms, materials, and commonly touched surfaces routinely during the day.



OR

NPI: Community

SCREENING

Students will be screened upon arrival and ENTRY WILL BE DENIED WHEN:

Displays one or more of the following <u>new or</u> <u>worsening</u> symptoms*:

- ✓ Fever (100 F, or higher) or Chills
- ✓ Cough
- ✓ Shortness of Breath or difficulty breathing
- ✓ Fatigue
- ✓ Muscle or body aches
- ✓ Headache
- ✓ New loss of taste or smell
- ✓ Sore Throat
- ✓ Nausea or vomiting

IN THE PREVIOUS 5 DAYS:

✓ Students having Close Contact with a person and/or household member who is COVID-19 positive.

*When symptoms are <u>medically diagnosed</u> as NOT related to COVID, the individual may enter with medical documentation.



SYMPTOMS & ILLNESS

If a student/staff member is displaying any <u>new or worsening</u> COVID-related symptoms <u>while at home</u>, then:

- ➤ Stay home
- ➤ Notify School Admin via email: <u>admissions@mhfcschool.com</u>
- Follow return to school criteria on pg. 14

If a family member of a child/staff in our school is displaying any <u>new or worsening</u> COVID-related symptoms, then:

- >Stay home, and follow return to school criteria on pg. 14
- >Closely monitor for <u>new or worsening</u> COVID-related symptoms, and
- >Immediately notify School Admin via email: admissions@mhfcschool.com if symptoms appear, and



SYMPTOMS & ILLNESS

If a <u>student/staff member</u> is displaying any <u>new or worsening</u> COVID-related symptoms <u>while</u> <u>at school</u>, then:

Student:

- > The individual and siblings will be moved to an isolated area.
- > Parents will be called for **immediate** pick-up
- > Follow guidelines for return on pg. 14

Staff:

> Staff members must **immediately** take a rapid COVID test. If positive, follow the criteria for return to school on pg. 15.



SYMPTOMS & ILLNESS:

If a <u>member of our school</u> is <u>confirmed positive</u> for COVID-19:

If student or staff, then:

- > Notify School Admin immediately via email: admissions@mhfcschool.com
- >> School will notify the Health Department and Childcare Licensing,
- >> Area used by person will be disinfected.
- >> School will notify staff and families of students in that class.
- >> Follow guidelines for return to school, pg. 15



SYMPTOMS & ILLNESS:

If a <u>household member</u> of a student is <u>confirmed positive</u> for COVID-19:

- >> Notify School Admin immediately via email: admissions@mhfcschool.com
- > The student (living with the household member) is presumed to have exposure to COVID
- > Follow guidelines for return to school, pg. 15



CRITERIA FOR NEW OR RETURNING STUDENTS & STAFF

New to School

- New students/staff are required to provide a negative rapid test result (administered within 24 hrs. of start date),
- New Employees are required to be fully vaccinated.

Return from Extended Break (5 or more consecutive days, including weekends, and unrelated to COVID infection, symptoms, or exposure)

- Returning students/staff must submit negative rapid test results (administered within 24 hrs. of returning to school).



SYMPTOMS & ILLNESS

CRITERIA FOR RETURN TO SCHOOL

In the case of an individual who is displaying new or worsening COVID-related symptoms:

- The individual is assumed to have COVID-19, and the individual may not return to school until the individual submits a note from a medical professional, clearing the individual with symptoms from active COVID-19 infection or a negative (rapid) COVID test administered within 24 hours of return to school.
- ➤ If the student is sent home due to fever or vomiting/diarrhea not related to COVID-19 infection must be symptom-free and without the need for fever-reducing medicine for 24 hrs. before returning to school.



SYMPTOMS & ILLNESS

CRITERIA FOR RETURN TO SCHOOL

In the case of an individual who is <u>diagnosed positive for COVID</u>, regardless of vaccination status:

- ➤ Isolate at home for a minimum of 5 days (day one begins at the onset of symptoms or, if asymptomatic, on the date of the positive test)
- ➤ If you have no symptoms, or your symptoms are resolving after 5 days, you may return to school on day 6, with the following:
 - > A negative rapid test result (administered on day 5 or after), and
 - > Ability to adhere to strict mask-wearing for an additional 5-days.

*If you are unable to adhere to 'strict mask-wearing (toddlers), you were severely ill with COVID-19, or immunocompromised, or do not test negative on day 5 or after, isolation could be extended to 10-days.

*Students may return to school on day 11 without a negative rapid COVID test result, provided symptoms have resolved and without the use of fever-reducing medication in the last 24 hours.



CLOSE CONTACT or EXPOSURE WITH AN INFECTED PERSON:

CRITERIA FOR RETURN TO SCHOOL:

When student has been in close contact or exposure with an infected person (other than a household member); quarantine/isolation <u>may</u> be determined on a case-by-case basis depending on close contact/exposure circumstances, vaccination status, and if the person has had COVID-19 within the past 90 days:

If you recovered from a documented COVID-19 infection within the past 90 days (regardless of vaccination status), you do NOT need to self-quarantine.



AFTER **DOMESTIC** TRAVEL CRITERIA FOR A RETURN TO SCHOOL:

ALL Travelers (regardless of vaccination status):

• Provide a negative RAPID test result (administered within 24 hrs.) prior to return to school.

AFTER INTERNATIONAL TRAVEL CRITERIA FOR A RETURN TO SCHOOL: :

If you are **NOT** up to date with COVID VACCINES:

- Stay home and quarantine for a full 5-days after travel, and
- Provide a negative RAPID test result (administered within 24 hrs.) prior to return to school

If you are up to date with COVID VACCINES:

Provide a negative RAPID test result (administered within 24 hrs.) prior to return to school

DEFINITIONS:

Close Contact: Is someone who was less than 6 feet away from an infected person (laboratory-confirmed or a clinical diagnosis) for a cumulative total of 15 minutes or more over a 24-hour period. For example, three individual 5-minute exposures for a total of 15 minutes. People who are exposed to someone with COVID-19 after they completed at least 5 days of isolation are not considered close contacts.

Exposure: Contact with someone infected with SARS-CoV-2, the virus that causes COVID-19, in a way that increases the likelihood of getting infected with the virus.

Quarantine: Is a strategy used to prevent transmission of COVID-19 by keeping people who have been in <u>close contact</u> with someone with COVID-19 apart from others.

Isolation: Is used to separate people with confirmed or suspected COVID-19 from those without COVID-19. People who are in isolation should stay home until it's safe for them to be around others.
